- A. Turkey Tournament

 - 2. We only made a \$5,837 profit. Toyota fields cost a lot.
 - 3. We will have a debriefing at a future meeting.
 - 4. There were 14 other tournaments on the same weekend.
- B. Area Playoffs 2 teams will be representing Region 16; GU14 and BU12
- C. Extra Playoffs 6 teams will be representing Region 16; GU14, GU12, GU11, GU10, GU09, BU13
- D. We have a good chance of at least one of our teams making it to the Western States Championship
- E. Coach Certifications coaches will now have to be properly certified at the beginning of the season
- F. AYSO Expo being held in Ontario. Highly recommend the board attend. There will be management and dispute resolution classes available.
- G. NAGM is in Chicago. After next year, this event will stay in California in Anaheim over Memorial Day weekend.
- H. National Games will be 7/5-7/10 in Palm Beach, Florida. Region 16 has 2 teams confirmed to attend. BU13 is pending.
- I. Dave Thomas has left UK International and will be running AYSO Academy. AYSO Academy will work as follows:
 - 1. Each division will have one Academy team.
 - 2. Each area will have one Academy team comprised of players from all regions in that area.
 - 3. Hoping to implement during the 2016-2017 season. Still working out the details, rules, etc.
 - 4. However, core program is still the priority. If not enough volunteers or players are available, Academy and Extra teams will be eliminated.
- J. Heading
 - 1. Will no longer be allowed or taught for U12 and younger starting this coming season.
 - 2. Heading during a game will be considered a dangerous play and a free kick will be awarded.
- K. Starting soon age cutoffs will be changed to the calendar year rather than the current July-June cutoff.
- L. Dick's Sporting Goods now has a contract with AYSO
- M. All region websites will need to convert to using Sombrero.
- N. Considering using CGI Program for scheduling, etc. Currently used by PV. It can handle scheduling, reports, ref schedules, ref points, standings, etc. Cost of program depends on which modules are being used. Cost is for a calendar year.
