AYSO REGION 16 MONTHLY BOARD MEETING McMaster Park - Torrance, CA Meeting Minutes June 20, 2016

I. Call to Order Jose Serrano

Meeting was called to order at 7:34 p.m.

II. Approval of Treasurer's Phil Quan Report

The Treasurer's Report was reviewed and approved.

III. Approval of Minutes Cayme Momita

The minutes from the May meeting will be reviewed and approved at the July 2016 meeting.

IV. Regional Commissioner Jose Serrano Report

- A. Chicago NAGM almost all of our area's regional commissioners were there. Region 16 donated \$1,000.00 to RC Valente Marin from Region 12 to cover medical expenses due to a medical issue he developed while on the trip. A GoFundMe account will be set up and we will post the link on our website when we receive it.
- B. New changes
 - 1. This is the last year U8s will have goalies. USF rules do not have goalies for U8. There will be 7 on the roster with 5 on the field. All soccer programs will go to this format.
 - 2. No heading will be allowed for U11 and younger. Coaches will be unable to teach any age younger than U11. This will affect team formation because now U11 and U12 should be kept separate. If divisions are combined, rules follow U11.
 - 3. Next season AYSO is going to follow club format and change to birth year to determine division placement. There will be single age groups.
 - 4. Ref changes
 - a. Webinar is available
 - b. Some changes mentioned can do kick backs at kick off, no need to kick it forward first; injured players no longer need to leave the field
- C. Election results are posted on ayso.org.
- D. Region 16 received an award for the 2015 year Presidential Award for an increase in registration
- E. There was no Area meeting. Area Coach Administrator has resigned so training for June has been cancelled.
- F. Each region will have its own policies that will be put into the National system. Region policies need to be posted on individual region websites. Flyers can also have region policies listed. National will honor regions' policies. Nationals need to have record of any policies that are outside of basic national policies. Receipts are required for reimbursements.
- G. Academy will begin next season. Orange County has a "Challenger" team that is similar. Academy will be run by Nationals. It will cost \$450/player. Right now \$20/player is paid to participate with the Core program. Extra is \$25/player additional. OC Challenger pays \$20/player plus Cal-South fees.
- H. Sombrero is the website Nationals will have every region use. Academy will begin when Sombrero is in place.

- I. Insurance procedures will be different. No coverage for outside vendors. All vendors must provide their own coverage (i.e. bubble soccer)
- J. City had a question about our storage containers. Stated that we need to consolidate our containers to lessen the number we have. We are still in negotiations with the City about the layout of the containers around the field.
- K. Snack bar is being redone. Work will hopefully be complete by the time the season starts.
- L. The schedule for this coming season will begin early and go later into the day to ease parking problems and referee coverage.
- M. Region photos we will be going back to Ultimate Exposures. We had so many complaints about last year's company. Board voted to go with the \$5/player option and have the photos mailed directly to the players. Photo day will be on 10/9 with 10/22 being the make-up date.

V. Assistant Regional Tony Warfield Commissioner

- A. Logo Contest
 - 1. Only 3 submissions so far 2 were from the same child
 - 2. Trying to drum up more interest.
 - 3. A cash prize will be offered.
- B. Storage bins will be relocated near Field 1. When redesign is complete, we'll need 2 weeks' notice to unload and move the bins.
- C. Tony will be sending out an email today listing the 10-20 webinars available regarding the rule changes

- A. Received emails from Area asking for ref classes. Area is waiting for everyone's dates before making the classes available
